- Conducting soil classification (a plus)
- Preparing technical reports, letters, and data tables

Ideal candidates should be organized, detail-oriented, safety-conscious, and eager to learn. Extended workdays and outdoor work in various weather conditions may be required.

**Project Scientist**

The Project Scientist will play a key role in assessing Conceptual Site Models and communicating with clients, property owners, and officials. In addition to many Field Inspector responsibilities, additional responsibilities include:

- Managing Immediate Response Actions, Release Abatement Measures, and Phase I & II investigations under the guidance of the LSP
- Collaborating with LSPs to advance project goals
- Evaluating project data and ensuring proper documentation

Successful candidates will be confident in their communication skills and capable of working independently under LSP supervision.

**Licensed Site Professional (LSP)**

The LSP will manage project phases under the MCP and work with environmental guidance policies, with responsibilities such as:

- Overseeing site assessments, sampling, and remediation techniques
- Managing junior staff and mentoring team members
- Maintaining client relationships and seeking new business opportunities

Candidates must have a strong knowledge of the MCP and associated guidance, with the ability to adapt to regulatory changes.
