David Foss, MassDEP Statewide Brownfields Coordinator, MassDEP – Bureau of Waste Site Cleanup David is a hydrogeologist with over 25-years' experience conducting and managing environmental assessment, remediation, and redevelopment at Brownfields sites. In addition to working directly for municipalities, he has collaborated with regional planning commissions, the US EPA, and MassDevelopment to promote redevelopment with a focus on areas with Environmental Justice concerns. On behalf of MassDEP, David is a member of the Regulatory Committee of BCONE (the Brownfields Coalition of the Northeast) and is the New England (EPA Region 1) representative of the ASTSWMO (Association of State and Territorial Solid Waste Management Officials) Brownfields Focus Group.
